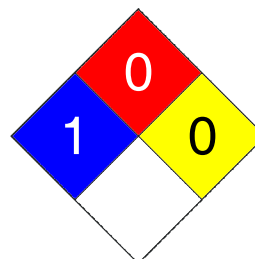

First aid procedures
